SHELTER RESOURCES

EMERGENCY SHELTER INSTRUCTIONS

Residents seeking shelter should bring:

- Prescription and emergency medication
- Medical equipment (I.E. oxygen, wheelchairs)
- Eyewear and/or glasses
- Extra clothing
- Pillows, blankets, sleeping bags and/or bedding
- Hygiene supplies and personal care items
- Flashlights with extra batteries
- Baby food, formula, diapers, and wipes
- Snacks and any food or drinks needed for dietary restrictions
- Beach and/or camping chairs
- Official documents, insurance and other important paperwork
- Pets (ONLY in a carrier), pet food and bowls, leashes, and veterinary records
- Entertainment for children

DEBRIS PICKUP

Debris pickup will be available through the county, only on state or county roads. If you live within city limits, contact your city for removal details.

Separating Your Debris
Debris should be placed curbside, without blocking the roadway or storm drains.

NO PICKUP ZONE
Any debris placed from the sidewalk toward your property will not be picked up.

DEBRIS SEPARATION
Separate debris into the six categories shown below.

DO NOT STACK OR LEAN
Placing debris near or on trees, poles, or other structures makes removal difficult. This includes fire hydrants and meters.

UNSURE WHERE TO PLACE DEBRIS?
If you don't have a sidewalk, ditch, or utility line in front of your house, place debris at the edge of your property before the curb.

Normal Household Trash
Normal household trash and bagged debris of any kind will not be picked up with disaster debris. You should continue to follow your normal garbage removal schedule.

VEGETATIVE DEBRIS

- Leaves (do not put in bags)
- Logs
- Plants
- Tree branches

CONSTRUCTION & DEMOLITION DEBRIS

- Building materials
- Carpet
- Drywall
- Furniture
- Lumber
- Mattresses
- Plumbing

APPLIANCES & WHITE GOODS

- Air conditioners
- Dishwashers
- Freezers
- Refrigerators
- Stoves
- Washers, dryers
- Water heaters

ELECTRONICS

- Computers
- Radios
- Stereos
- Televisions
- Other devices with a cord

HOUSEHOLD HAZARDOUS WASTE

- Cleaning supplies
- Batteries
- Lawn chemicals
- Oils
- Oil-based paints and stains
- Pesticides

The Brazoria County Water Lab (BCWL) is waiving the testing fee for Brazoria County residents. Water samples will be tested for coliform and E.coli bacteria. Please reach out to the BCWL for instructions on how to disinfect and properly collect water samples. Residents must provide their address and water must be collected using a sample container provided by the BCWL.

FEMA DISASTER ASSISTANCE

Shelter Assistance

FEMA Transitional Shelter Assistance (“TSA”) Program

***Note* Certain hotels have contracts with FEMA to provide temporary housing. This program closes for those impacted by Harvey on SEP. 26, 2017.**

The FEMA app has disaster safety tips, an interactive emergency kit list, storable emergency meeting locations, and a map with open shelters and open FEMA Disaster Recovery Centers (DRCs).

FEMA Assistance

Individuals and business owners who sustained losses can begin applying for assistance by registering online at www.DisasterAssistance.gov or by calling 1.800.621.FEMA (3362). Disaster assistance applicants, who have a speech disability or hearing loss and use TTY, should call 1.800.462.7585 directly; for those who use 711 or Video Relay Service (VRS), call 1.800.621.3362.

***Note* The toll-free telephone numbers will operate from 7 a.m. to 10 p.m. (local time) seven days a week until further notice.**

FEMA Disaster Recovery Center Locator

The Disaster Recovery Center (DRC) Locator allows individuals to search for DRCs nearest to their location. DRC Locator also provides additional information about each DRC, such as hours of operation, services offered, and driving directions to the DRC.

TEXAS WORKFORCE COMMISSION

To apply for the Disaster Unemployment Assistance Program, call the Texas Workforce Commission at **1.800.939.6631** or apply online at <https://buff.ly/2x0YINh>. Reference the disaster declaration DR-4332.

***Note* Applications will only be accepted through SEP. 27, 2017.**

Individuals affected by the recent severe storms in the following counties can apply for benefits online through [Unemployment Benefit Services](#) or by calling a TWC Tele-Center Monday through Friday between 8 a.m. and 5 p.m. at 800-939-6631: **Aransas, Bee, Brazoria, Calhoun, Chambers, Fort Bend, Galveston, Goliad, Harris, Jackson, Kleberg, Liberty, Matagorda, Nueces, Refugio, San Patricio, Victoria, and Wharton Counties. Individuals should specify that their applications are related to the damage caused by Hurricane Harvey.**

To receive DUA benefits, all required documentation must be submitted within 21 days from the day the DUA application is filed. Required documentation includes Social Security number, a copy of the most recent federal income tax form or check stubs, or documentation to support that you were working or self-employed when the disaster occurred.

Applicants must mail in or fax all required documentation within 21 days from the date of the DUA application.

EMERGENCY SUPPLEMENTAL NUTRITION ASSISTANCE

Information updated as of 09/01/2017.

For current recipients of the Supplemental Nutrition Assistance Program (SNAP)

- On August 31, FNS approved the State's request to issue automatic mass replacements of SNAP benefits as follows to the counties of Angelina, Atascosa, Austin, Bastrop, Bexar, Brazos, Burleson, Caldwell, Cameron, Colorado, Comal, DeWitt, Fayette, Gonzales, Grimes, Guadalupe, Hardin, Jasper, Jefferson, Jim Wells, Karnes, Kerr, Lavaca, Lee, Leon, Live Oak, Madison, Montgomery, Newton, Orange, Polk, Sabine, San Jacinto, Trinity, Tyler, Walker, Waller, Washington, Willacy, and Wilson.
- FNS also approved the State's request to issue automatic mass replacements of SNAP benefits as follows to the counties of Aransas, Bee, Brazoria, Calhoun, Chambers, Fort Bend, Galveston, Goliad, Harris, Jackson, Kleberg, Liberty, Matagorda, Nueces, Refugio, San Patricio, Victoria, and Wharton.

These replacement benefits will be automatically issued to all regular SNAP households in the affected counties, by means of an automated credit to their Electronic Benefits Transfer (EBT) cards. Households that have already received replacement benefits based on a signed affidavit of loss must be excluded from the mass replacement process. Furthermore, if a client submits an affidavit after receiving a mass replacement and requests an amount greater than the replacement benefit amount received, the household is only entitled to receive the difference between the requested amount and the amount previously replaced. Replacement benefits cannot exceed the maximum monthly allotment for the household.

- FNS approved the State's request to waive the 10-day reporting requirement for replacement of food purchased with August 2017 SNAP benefits destroyed in Angelina, Aransas, Atascosa, Austin, Bastrop, Bee, Bexar, Brazoria, Brazos, Burleson, Caldwell, Calhoun, Cameron, Chambers, Colorado, Comal, DeWitt, Fayette, Fort Bend, Galveston, Goliad, Gonzales, Grimes, Guadalupe, Hardin, Harris, Jackson, Jasper, Jefferson, Jim Wells, Karnes, Kerr, Kleberg, Lavaca, Lee, Leon, Liberty, Live Oak, Madison, Matagorda, Montgomery, Newton, Nueces, Orange, Polk, Refugio, Sabine, San Jacinto, San Patricio, Trinity, Tyler, Victoria, Walker, Waller, Washington, Wharton, Willacy, and Wilson Counties. **Affected households have until September 30, 2017, to report food losses to their local offices and request replacement benefits.**

- FNS approved the State's hot foods' waiver request to allow recipients to purchase hot foods and hot food products prepared for immediate consumption with their benefits at authorized SNAP retailers statewide through **September 30, 2017**. [Texas Hot Foods Notice](#)

Regarding application for the Disaster Supplemental Nutrition Assistance Program (D-SNAP)

***Note* As of Tuesday, SEP. 12, 2017, D-SNAP application centers have NOT been launched in Brazoria County, TX. The D-SNAP launch date is TBD.**

UWBC is continuing to monitor the activation process of this service and will communicate when it has become fully activated for residents of Brazoria County.
